PUBLIC SECTOR COLLECTIVE BARGAINING

CONCEPTS Concepts such as competition, market economy, and free contracts are defining characteristics in the private sector, whereas government is characterized by monopoly, politics, and sovereignty.

HOSTILITY The doctrine of hostility between parties is fundamental to traditional collective bargaining (adversarial, conflictual, confrontational).

COOPERATIVE Cooperative problem solving is more likely to succeed when there is mutual trust, commitment, and leadership from all participants as well as from flexible, adaptive organizational structures.

WIN-WIN Although it is important not to oversell win-win bargaining and harmony-based solutions or to undervalue the merits of traditional bargaining, these examples suggest that public unions and managers should explore diverse paths.
